Skills Training Center - A project currently under construction to create a training center for adults living in the upper Amazon River regions of Peru that will provide practical skills that can use to begin small businesses. Subject areas will include small engine repair, welding and carpentry. The training will include classroom theory, hands on skills training, and how to operate a small business using biblically based practices. Threaded throughout all the coursework will be intentional discipleship in how to live lives that are honoring to God. The school is under construction, with the property purchased, well drilled, interior roads constructed and storage building completed.

4b (Code:) (Expenses \$ 27,625 including grants of \$) (Revenue \$ 0)

Mission Outreach Center in Nauta: JungleMaster Ministries operates a base in Nauta, Peru. It is used as a no-cost way station for pastors and other leaders as they travel along the Amazon river between their own home villages to/from the city of Iquitos, Peru to conduct business. This base is also used as a facility to host technical mechanical skills training for local Peruvian nationals. This base is also where JungleMaster Ministries' full time missionary lives.

Leadership Training - JungleMaster Ministries has partnered with the Global Leadership Network - Peru to host Global Leadership Summit (GLS) events in Iquitos, Peru. The GLS inspires leaders to grow their leadership abilities in order to further influence the world for God. Church pastors and other community leaders are invited to attend the leadership training.
