Skills Training Center - A new project to create a training center for adults living in the upper Amazon River regions of Peru that will provide practical skills that can use to begin small businesses. Subject areas will include small engine repair, welding and carpentry. The training will include classroom theory, hands on skills training, and how to operate a small business using biblically based practices. Threaded throughout all the coursework will be intentional discipleship in how to live lives that are honoring to God. The school is under construction, with the property purchased, well drilled, entry road constructed and storage building completed. 2021 was the first year of a multi-year construction timeframe.

4b (Code:) (Expenses \$ 30,278 including grants of \$ 0) (Revenue \$ 0)

Mission Outreach Center in Nauta: JungleMaster Ministries operates a base in Nauta, Peru. It is used as a no-cost way station for pastors and other leaders as they travel along the Amazon river from their own home villages to the city of Iquitos, Peru to conduct business. This base is also used as a facility to host technical mechanical skills training for local Peruvian nationals. This base is also where JungleMaster Ministries' full time missionary lives.

4c (Code:) (Expenses \$ 25,719 including grants of \$ 0) (Revenue \$ 0)

Amazon Small Village Assistance Programs: Provides financial assistance in the way of scholarships and travel assistance to Christian pastors and leaders from jungle river villages to attend seminary school. Also provides financial and resource assistance to villages for the construction of churches and various small projects. Also provides financial assistance for emergency medical care, and assists in organizing youth oriented sports programs to promote character development and leadership skills.

Form 990, Part III, Line 2 - JungleMaster Ministries initiated a project to create a training center that will provide practical skills that adult students can use to begin small businesses. Subject areas will include small engine repair, welding and carpentry. The training will include classroom theory, hands on skills training, and small business practices. Threaded throughout all the coursework will be intentional discipleship in how to live lives that are honoring to God.

Form 990, Part III, Line 3 - The Cofraternity of Pastors Program was discontinued in early 2021 due to insufficient evidence of the program meeting the intended purpose.

Form 990, Part VI, Section A, Line 2 - The person filling the role of Executive Director (a paid position) also served as the Board Chair (an unpaid position). Also, two of the directors are husband and wife. In April 2022, to resolve the issue of non-independent board members, one of the two related persons resigned from the Board. As a result of the above actions, the answer to Part VI Line 1 (b) would change to "5".

Form 990, Part VI, Section B, Line 11b - The completed 2021 990 form was emailed to all board members along with a letter which summarized the major items of interest. The document was also discussed at the JungleMaster Ministries April 2022 board meeting. As a result of the review, the Board recognized a need for, and adopted the following: 1) A Conflict of Interest Policy; 2) A Conflict of Interest Annual Declaration Policy; and 3) A Document Retention and Destruction Policy.

Form 990, Part VI, Section C, Line 19 - The Conflict of Interest and Document Retention/Destruction Policies did not exist until their adoption by the JMM Board in April 2022. There are no known past ethical violations of the policies, had they been in place earlier. These new policies, along with governing documents and financial statements are all available for inspection by the public upon request.

Form 990, Part XI, Line 9 - Equipment sold for less than booked asset value. Also an adjustment for a \$1 rounding error.
